STUDENT'S RIGHT TO CANCEL

STUDENT'S RIGHT TO CANCEL

1. According to California Educational Code section 94919 (d), the student has the right to cancel and obtain a refund of charges paid through attendance at the first-class session, or the seventh day after enrollment, whichever is later.
2. If the student has received federal student financial aid funds, the student is entitled to a refund of money not paid from federal student financial aid program funds.
3. Read the Cancellation policy for an explanation of your rights and responsibilities. If you have lost your Notice of Cancellation, ask the school for a sample copy.
4. After the end of the cancellation period, you also have the right to stop school at any time; and **you have the right to receive a pro-rate refund**. Pro rata refunds are only given to students who have attended 60% or less of the program.

Your refunds rights are described in the contract. If you have lost your contract, ask the school for a description of the refund policy. If the school closes before you graduate, you may be entitled to a refund.
